# **TERMS OF AGREEMENT**

# **REAL PROPERTY**

For ALL real property, please provide the following:

- 1. Address
- 2. Name(s) on Deed
- 3. Name(s) on Indebtedness/mortgage/line of credit
- 4. Indebtedness owed on/secured by the property/properties, if any
- 5. Who pays the indebtedness?
- 6. Who is property being awarded to, Husband or Wife?
- 7. Is there a requirement for a party to refinance? If so, within what time period?
- 8. Is there an equity payout to the other party? If so, by when?

If the property is being listed for sale, please provide the following:

- 1. Realtor (and company)
- 2. Date to be listed by
- 3. Who is residing in the property until sold?
- 4. Who is responsible for the indebtedness, expenses, taxes, insurance, etc. until sold?
- 5. Who has final decision-making authority over asking price/selling price/etc?
- 6. How are the proceeds divided?

# **PERSONAL PROPERTY**

These are the options:

- 1. Each party is awarded the personal property in his/her current possession (this means the personal property is already split up)
- 2. Wife is awarded the personal property located in the residence; however, Husband is awarded the following: PROVIDE LIST
- 3. Husband is awarded the personal property located in the residence; however, Wife is awarded the following: PROVIDE LIST

### **VEHICLES**

For ALL vehicles (including boats, jet ski's, trailers, campers, RV's, etc), please provide the following:

- 1. Make and model
- 2. Name(s) on title
- 3. Name(s) on indebtedness
- 4. Indebtedness owed on the vehicle(s), if any
- 5. Who pays the indebtedness?
- 6. Who is awarded each vehicle?
- 7. Is there a requirement for a party to refinance? If so, within what time period?

# **BANKING ACCOUNTS**

Do you have any joint banking accounts? If so, we need the following:

- 1. Bank
- 2. Type of account (checking/savings)
- 3. Last 4 digits of account number
- 4. Balance
- 5. Who is awarded the account(s)?
- 6. How is the money in the account(s) to be divided?

## **RETIREMENT ACCOUNTS**

For each retirement account, please provide the following:

- 1. Name on retirement account
- 2. What type of account
- 3. Who is awarded each account?
- If either party is awarded a portion of the other's retirement, please state how much that party is awarded and provide a current statement (need an amount or percentage).
- 5. If a QDRO (this is an order whereby transferring the retirement money to the other party) is needed who is responsible for paying for the QDRO to be prepared, executed and submitted?

# **BUSINESS**

Is there a business? If so, what is the legal name of the business and who is awarded same?

#### <u>ALIMONY</u>

Is either party awarded alimony? If so, we need monthly amount and duration of same. Is it modifiable/non-modifiable?

# **ATTORNEY'S FEES**

Is either party paying attorney's fees? If so, we need the amount and when it will be paid by.

### MAIDEN NAME

Does Wife want her name maiden name restored? If so, we need how she specifically wants it to read. FIRST NAME; MIDDLE NAME; LAST NAME

# **TAX RETURNS**

Is there a joint tax return that needs to be filed? If so, what for what year? Who is responsible for the tax liability? Who is awarded the tax refund? Who will file (party or

CPA)? When do the documents (in order to prepare tax return) need to be submitted to the party or CPA by (looking for a date)?

#### **INSURANCE**

Is there a requirement for either party to maintain health insurance on the other until the parties are divorced? This is with the understanding that once you are divorced, you can no longer carry insurance for the other as you are no longer related.

# **JOINT DEBT**

Do you have any joint debt (ie credit cards, loans – excluding vehicle and mortgage loans as they are addressed above, etc.)? If so, we need the following:

# **CUSTODY**

Joint legal custody with \_\_\_mom OR dad\_\_\_\_\_ being primary physical custodian.

\*\*If it is joint legal and joint physical custody only, then we need the following:

- 1. How is the payment on extra-curricular activity expenses incurred for the minor children to be paid? For example, 50/50 each party pays half; 80/20 one parry pays 80% and the other pays 20% of said expenses; etc.
- 2. How is the payment on school expenses incurred for the minor children to be paid?
- 3. Who has final decision making authority in the following categories please list Mom OR Dad.
  - a. Educational decisions
  - b. Non-emergency health care
  - c. Religious upbringing

#### d. Extracurricular activities

# **VISITATION**

See the attached Parenting Plan/Visitation schedule. Please let us know what specific changes you agree to – please write on the document your exact changes that you want.

# **CHILD SUPPORT**

Do you agree on a child support amount?

- 3. Who is required to provide health insurance on the minor children?
- 4. Need amount of health insurance for the children <u>only</u>: please provide the statement from HR showing the breakdown of the insurance (where it shows employee only cost; employee + spouse; employee + family; etc.)
- 5. Are there daycare expenses? If so, we need for each child:
  - a. Daycare expense per week broken down. (for example: \$120/week during school year; \$150/week during the summer and holidays)
- 6. Uncovered healthcare expenses will these be split equally between mom and dad?
